#### **Terms and conditions:**

- I. The vehicle will be disposed off by auction *cum quotation basis on* "As is where is basis". The auction process will be conducted in the presence of auction committee of this office.
- II. The auction shall be conducted on 22/05/2023 at 03:00 pm in this office premises.
- III. The bidders are required to pay Earnest Money Deposit (EMD) of Rs,5000/- (Rupees Five Thousand) for Tata-407&Swaraj Mazda, Rs.1000/- (Rupees One thousand) for Ambassdor & Maruthi van, payable by means of Demand draft drawn in favor of Sports Authority of India, NSSC, Bangalore and the EMD to be deposited along with the sealed tender.
- IV. Tender received without demand draft towards EMD will not be considered in the auction.
- V. The successful bidder will be required to deposit the bid amount by means of demand draft drawn in favor of Sports Authority of India, NSSC, Bangalore within four working days of the acceptance of the bid or by RTGS/NEFT.
